## 1 Introduction

Welcome to **Rehan School Foundation Level**.

Rehan School is an experimental AI-first educational system designed to explore, develop, refine, and improve methods of educating students for the post-AI era.

Our mission is to use:

- Mobile Devices
- Computing Power
- Real-world Communication
- Project-based Learning
- Self-learning Systems

...to maximize the confidence, communication ability, leadership, creativity, adaptability, future readiness, and earning potential of students.

By enrolling a child into the Rehan School Foundation Level, the Parent/Guardian automatically agrees to and accepts all terms listed in this agreement.

## 2 Experimental Nature of Rehan School

The Parent/Guardian understands and accepts that Rehan School is an experimental and evolving educational system.

Unlike traditional schools, Rehan School continuously experiments with:

- Curriculum
- Teaching methods
- AI tools
- Digital systems
- Communication systems

The Parent/Guardian acknowledges that:

- many systems may change frequently,
- some experiments may succeed,
- some experiments may fail,
- and the school may rapidly adapt and modify its systems at any time.

Rehan School reserves the right to make operational, educational, technological, or structural changes without prior notice whenever deemed necessary.

### 3 Foundation Level Structure

The Foundation Level currently requires approximately **one (1) hour of participation per day**.

The program may include:

- Online learning
- Physical classes
- AI-based learning
- Video-based learning
- Internet research
- Communication exercises
- Social media exposure
- Digital assignments
- Self-learning tasks
- Parent participation

The Parent/Guardian understands that the Foundation Level is designed primarily as an *introduction and exposure* to the Rehan School system.

### 4 Existing Schooling System

Rehan School strongly advises all parents **NOT to discontinue** their child's existing traditional schooling system while enrolled in Foundation Level.



Foundation Level is intended to work alongside the student's current school system.

If the Parent/Guardian independently decides to:

- remove the child from another school,
- discontinue traditional schooling,
- homeschool the child,
- or make any educational change based on their own decision,

then Rehan School, its founders, staff, teachers, representatives, volunteers, interns, and affiliates shall **NOT** be held responsible for:

- academic consequences,
- board examination issues,
- recognition issues,
- career consequences,
- emotional consequences,
- financial consequences,
- educational gaps,
- or any future difficulties arising from such decisions.

These decisions remain **solely the responsibility of the Parent/Guardian**.

## 5 Challenges of the System

The Parent/Guardian acknowledges that:

- Rehan School may not be suitable for every student.
- Some students may struggle with the learning style.
- Some students may struggle with self-learning requirements.
- Some parents may struggle with the expectations, communication style, pace, or experimental nature of the system.
- The school requires adaptability, consistency, participation, and openness to change.

The Parent/Guardian accepts that dissatisfaction arising solely from the experimental nature of the system shall not be considered fraud, negligence, or misrepresentation.

## 6 Foundation Level Does Not Guarantee Level 1 Admission

**Completion of the Rehan School Foundation Level DOES NOT guarantee admission into Rehan School Level 1.**

Foundation Level is only a pre-requirement and introductory exposure program designed to help:

- the student,
- the father,
- the mother,
- and the family

understand the philosophy, systems, expectations, and educational approach of Rehan School.

The Foundation Level exists so families can experience and evaluate the Rehan School system before applying for Level 1 admission.

Admission into Rehan School Level 1 is **highly selective** and is decided solely at the discretion of the Rehan School Admission Board.

Admission decisions may be based on factors including but not limited to:

- Student skill level
- Communication ability
- Consistency
- Learning attitude
- Discipline
- Curiosity
- Parent involvement
- Adaptability
- Self-learning ability
- Work ethic
- Emotional maturity
- Leadership potential
- Alignment with Rehan School goals and values

The Parent/Guardian understands that Rehan School has extremely high goals for its students and acknowledges that not every student may be suitable for Level 1.

Rehan School reserves the absolute right to:

- accept,
- reject,
- delay,
- defer,
- or refuse admission

to any student for any reason deemed appropriate by the Admission Board.

Completion of Foundation Level shall **not create any automatic right** to admission into Level 1.



## **7 Parental Participation Requirement**

The Parent/Guardian understands that Rehan School believes student transformation requires family participation.

For Level 1 consideration, Rehan School may require that:

- the student completes Foundation Level,
- the father completes the Foundation Level Book,
- and the mother completes the Foundation Level Book,

...or equivalent tasks assigned by Rehan School.

The school believes alignment between the child and family is critical for success within the system.

## **8 ACCL Program Option**

Students who are not admitted into Level 1, or who choose not to apply for Level 1, may still continue learning through:

- ACCL Level 1
- ACCL Level 2
- ACCL Level 3
- ACCL Level 4

These programs are designed to work alongside traditional schooling systems while allowing students to continue learning with Rehan School for approximately one hour per day.

## **9 Technology, Internet, and AI Consent**

The Parent/Guardian understands and accepts that the student may use:

- AI tools,
- online platforms,
- internet resources,
- social media platforms,
- mobile applications,
- video platforms,
- communication systems,
- and third-party software

...as part of the educational process.



While Rehan School attempts to guide students responsibly, the Parent/Guardian acknowledges that complete control over internet content and third-party platforms is not possible.

**Parents are strongly encouraged to supervise students independently.**

## 10 Media, Content, and Communication Consent

The Parent/Guardian understands and accepts that students may appear in:

- photographs,
- videos,
- podcasts,
- online sessions,
- social media posts,
- educational materials,
- marketing materials,
- documentaries,
- and public communication content

...created by Rehan School.

Unless explicitly requested in writing, Rehan School may use such content for educational, promotional, training, operational, and communication purposes.

## 11 Two-Month Refund Policy

Rehan School understands that our educational system is highly experimental, unconventional, and different from traditional schooling systems.

We also understand that:

- some students may not adapt comfortably,
- some parents may not agree with the methodology,
- or the system may simply not suit a particular family.

Therefore, Rehan School offers a **two (2) month evaluation and refund period**.

If, for any reason whatsoever, the Parent/Guardian decides within the first two (2) months from the date of enrollment that they do not wish to continue with the Foundation Level program, they may cancel the admission.



Upon such cancellation within the first two (2) months:

- the Parent/Guardian shall be eligible for a **full refund** of the fees paid to Rehan School for the Foundation Level program.

After the completion of two (2) months from the enrollment date:

- no refund shall be applicable,
- no partial refund shall be applicable,
- and the Parent/Guardian voluntarily waives any refund claim thereafter.

The Parent/Guardian acknowledges and agrees that the two-month period is sufficient time to:

- understand the Rehan School system,
- evaluate the educational methodology,
- observe the child's compatibility,
- and make an informed decision regarding continuation.

Rehan School has no objection if a family decides the system is not suitable for them during this initial evaluation period.

## 12 Limitation of Liability

The Parent/Guardian agrees that Rehan School, its founders, management, staff, teachers, interns, volunteers, affiliates, and representatives shall **not be held liable** for:

- educational outcomes,
- income outcomes,
- emotional adaptation issues,
- internet-related exposure,
- technology-related issues,
- student performance variations,
- dissatisfaction arising from experimental methodologies,
- non-selection into Level 1,
- or decisions independently made by the family.

Participation in Rehan School programs is voluntary and based on the Parent/Guardian's own judgment.
